



## Treatment Planning

- In accordance with the concept of the Golden Thread the direction of the treatment plan's goals, objectives, interventions and group assignments can be directly linked back to the assessment.
- The individual's treatment plan acts as the guiding force behind the delivery of care.





# Treatment Planning

The treatment plan has the following essential elements:

- ✓ Shared Decision-Making
- ✓ Problem Statement
- ✓ Goals
- ✓ Action Steps
- ✓ Interventions
- ✓ Service Description

# Development of a Group Menu



- Examine and Re-Examine the Population of the Program
  - Ongoing process
- Flexible Topics
- Evidenced-Based
- Support Staff Training



## Matching Individuals with Groups

- Collaboration/individual choice
- Measuring ongoing progress and appropriateness
- SNAP
- Program's resources
- The nature of the group and/or groups available.





### **Documentation of Group**



- Linkage to the treatment plan
- Expression of progress through treatment
- Response to the interventions
- Each group member has an individualized note completed by the group counselor



### Documentation of Group

- DAP or SOAP notes can be utilized to document group session
  - DAP: Data, Assessment, Plan
  - SOAP: Subjective, Objective, Assessment, Plan
- Notes should include:
  - Group topic, activities completed during group session (whole group)
  - Any information observed about the individual or measured during group
  - Assessment of individual's response to group; this should be clinical
  - Plan for future groups





#### Person-Centered Documentation



- #1 Reason: Reduce Stigma
  - Increase engagement
  - Decrease fear and shame
  - Increase quality of care
- Reflects Trauma-Informed Care
- Shatterproof | Reversing the Addiction Crisis in the U.S.



#### Reassessment of Individual Needs

- ASAM Continued Reassessment Ensures
  - Patient-Directed Care
  - Outcome-Driven Approach
- Poor outcomes at any given level of care warrant a reassessment of the treatment plan.
  - Update treatment plan
  - Update group
  - Update type of service/intervention
- New information
  - Cognitive functioning
  - Co-occurring
  - Clinical cues documented from individual or group session





# Considerations for Individualizing Care

- Golden Thread
- Utilize treatment planning in session
- Consultation
- Create internal tool and utilize chart audits
